Consequently, revenues and the profitability have been adversely affected in over.</p> <p>However, The Company's operations have been discontinued due to possession of factory taken over by Edelweiss Asset Reconstruction Company Limited (EARC).</p> <p>The factory located at Satara physically under control of EARC due to default in payment of term loan secured against the factory premises and the company does not have any production or trading activity.</p> <p>Recently, we have been informed by Edelweiss Asset Reconstruction Company Limited (EARC) who is in the possession of all the Assets of the Company that they have entered into an Agreement for sale of assets of the Company to third Party under private treaty. For which we have informed to the Exchange accordingly vide our letter dated 22<sup>nd</sup> May,2020.</p> <p>Company is already in a loss due to discontinued operation of the company so there is no major impact on the business of the company due to Covid-19 pandemic.</p>
