6. As per the communication received from Edelweiss Asset Reconstruction Company the Assets of the company has been sold to the

private entity but has not been recorded in books of accounts due to absense of proper information and documents.

7. Covid-19 Disclosure:-Company is already in a loss due to Discontinued operation and there is no chance of restart of the oprations so there is no major impact on the business of the company due to Covid-19 pandemic.
