Plant and machinery

Tricom Fruits has invested in a fully automated, integrated, multi- fruit processing plant. International grade quality processing being paramount, the company has invested in the best available machinery sourced from Internationally-renowned manufacturers including Alfa Laval, Blue Star, Linde and J N Marshall.

With international grade processing facilities and capacity to process 10 tonnes of fruit per hour, the company is fully geared to deliver large quantities on time and adhere to the strict order processing guidelines.

Wide range of products

The company is engaged in processing of wide range of fruits including Mango, Pomegranate, Guava, Tomato, Papaya, Banana and Gooseberry (Amla).

Products from these fruits are supplied in the form of puree, puree concentrate and frozen clear juice concentrate.

The orders are exclusively customised and processed as aseptic or, frozen as per the customers' requirements. With access to good quality raw material and technology imbining speed and quality, the company offers globally competitive prices for its products.

Quality commitment

The company intends to supersede customers' satisfaction parameters by always delivering quality products on time. This is achieved through established quality supply chain systems and stringent quality checks at each stage of processing. A state-of-the-art laboratory with latest testing equipments has been set up within the premises. Special care and attention has been paid to hygiene at each stage of processing.

- ◆ Multi-production facility to produce puree to frozen clear juice concentrate for array of fruits.
- ◆ Ability to switch processing from one product to the other in less than a day's time.
- ◆ Well-planned construction based on sequential processing stage right from the raw material storage area to preparatory processing, packaging & finished products storage area.
- ◆ Construction carefully planned to facilitate maximum cleanliness, hygiene and quality control.
